### <u>A PeRsOnalized Prevention roadmap for the future HEalThcare (PROPHET)</u>

The shift from treating established diseases to focusing on prevention presents a significant challenge. The development of targeted interventions marks a promising paradigm shift, positioning personalized approaches as the future of preventive healthcare. In this context, PROPHET has supported and continues to champion the implementation of innovative, sustainable, and effective personalized programs aimed at preventing common chronic diseases through the creation of a Strategic Research and Innovation Agenda (SRIA).

The project engaged a diverse range of stakeholders, including citizens, patients, and health professionals, who provided valuable insights on mapping the latest research advancements in personalized prevention as well as on capacity-building activities. Led by the Catholic University of the Sacred Heart, the project involves a consortium of 17 grant recipients and 2 affiliated entities across 12 EU member states, working to realize the promise of personalized healthcare..

#### Joint Action Prevent Non-Communicable Diseases and Cancer (JA PreventNCD)

Cancer and other non-communicable diseases (NCDs) represent a significant portion of the disease burden in Europe, much of which is preventable. The Joint Action Prevent Non-Communicable Diseases (JA PreventNCD) project is designed to address this challenge by supporting strategies and policies that aim to reduce the burden of cancer and NCDs, focusing on both personal and societal risk factors.

The project's major goal is to minimise fragmentation and duplication of efforts and to engage national authorities at various levels to enhance the impact of actions taken. A significant aspect is the rigorous evaluation of these actions to assist authorities in prioritising the most effective prevention strategies. This will contribute to achieving global targets in reducing the NCD burden.











A key objective is to tackle social inequalities by addressing the root causes of NCD risk factors and adopting a life-course approach. The project aims to build a comprehensive European infrastructure for monitoring factors related to cancer and other NCDs. This includes building on existing knowledge and exploring new methods for monitoring risk factors, disease burden, and the impact of policies and interventions. The project emphasises that health is created by policies across sectors, and thus, it is crucial to consider the health and health equity implications of these policies.

#### Joint Action of the EU on Networks of Expertise on Cancer (JANE-2)

The second Joint Action of the EU on Networks of Expertise on Cancer (JANE-2) brings toghether 122 partners from 29 European countries. Its mission is to create seven Networks of Expertise on cancer in the EU, on: • complex and poor-prognosis cancers; • palliative cancer care; • survivorship; • personalized primary and secondary prevention; • omics technologies; • hi-tech medical resources; • adolescents and young adult patients with tumours.

The new Networks of Expertise will provide services to the whole European oncology community, such as: clinical practice guidelines and recommendations; quality of care criteria; health care and economic models; educational support; research promotion; support to patient advocates; support to political advocacy; and most importantly – everything with patients at the centre.
